

INFORMATION OBLIGATION WITH THE COLLECTION OF PERSONAL DATA ACCORDING TO THE GENERAL DATA PROTECTION REGULATION

Johannes Kepler University of Linz (hereinafter "JKU") informs you below about the processing of your personal data (more precisely: personal data that refer to you) within the meaning of Art. 4 Subclause 1 General Data Protection Regulation (hereinafter "GDPR"), which the applicable data protection law serves to protect¹. "Processing", within the meaning of Art. 4 Subclause 2 GDPR, is in particular the collection, recording and storage of personal data with or without the aid of automated (technical) processes.

I. Contact data of the controller:

II. Background of the processing / statement of the purpose, for which the personal data are to be processed / legal basis of the processing / recipients of the personal data:

1. As part of your voluntary participation in the "Autonomous Driving" experiment, JKU processes personal data about you as a test person, such as your first and last names, as well as the images and video material taken of you while driving. The recordings are used to observe and evaluate your eye and steering movements as well as all other behavior while driving.

The processing of your personal data in the context of the above experiment is carried out for scientific research purposes in the public interest. This experiment investigates the effect of haptic guidance on driving performance after a takeover request to avoid sudden obstacles on the road. By observing human behavior, it is intended to develop safe mathematical algorithms that can predict specific behavior when an autonomously driving motor vehicle encounters a manually controlled motor vehicle. Against this background, the results/knowledge/evaluations gained from this experiment, without information that could lead to your identification, can thus be processed exclusively in anonymized form, also in scientific publications and presented at scientific conferences, congresses, seminars and teaching events. Overall, your data will

therefore be processed for the purpose of organizational and administrative management of the above experiment.

2. The legal basis for the processing of your personal data is your voluntary consent pursuant to Art. 6 Para. 1 letter a and 9 Para. 2 letter a GDPR.

Pursuant to **Art. 7 Para. 3 GDPR** you have the right, without stating any reasons, to exercise your right of revocation and to change the granted consent with effect for the future or to revoke it in full by post by using the contact data cited under Point **I.** or by email to datenschutz@jku.at. The lawfulness of the processing of your personal data carried out based on the consent until the revocation will not be affected by the revocation of your consent.

3. Recipients

The recipients of the personal data are the organizational units of JKU necessary for the corresponding processing - in particular the Chair Sustainable Transportation Logistics 4.0 - as well as any commissioned processors used in the context of technical support, hosting, maintenance and administration, insofar as access by them to personal data cannot be excluded by technical and organizational measures.

As already explained under point **II.1.**, the results/knowledge/evaluations gained from the experiment can be published in anonymized form as a scientific paper in various relevant scientific publication media (print media as well as online publications via the Internet) and presented at scientific conferences, congresses, seminars and teaching events.

III. Details regarding the storage duration:

The storage or processing of your data is carried out in accordance with the criteria specified for the storage period, such as the timeliness and relevance with regard to the purpose stated under point **II.1** or until the declaration of consent is revoked.

The image and video material is post-processed after production/recording in such a way that it is no longer possible to trace it back to specific data subjects. Any copies of the image or video material containing personal data will be deleted immediately after faces have been rendered unrecognizable, unless there are other legitimate interests of JKU that justify further storage.
